
## Why Whales Sing

## **Traitor**

The Life and Assassination of John Dunn Hunter, American Radical ANDY DOOLEN

John Dunn Hunter was many things: a frontier hero, a writer, a celebrity at home and abroad, and, ultimately, the victim of a deadly conspiracy. Born to white parents in 1800, he was captured as a young child by the Kickapoo and later raised by the Kansa and then the Osage. As a young man, he left his Osage family and crossed the Mississippi into the United States, where he became an ardent and persuasive voice in favor of Indigenous sovereignty in the face of western expansion and the removal of native populations.

In this gripping biography, Andy Doolen chronicles Hunter's compelling life and disgraceful murder. Often referred to as the "white Indian," Hunter published a gripping account of his life story and held court with esteemed figures of his day, from Presidents Jefferson and Madison to the Duke of Sussex and visionary reformer Robert Owen. But advocating for the rights of Indigenous people and nations painted a target on his back. Officials in the War Department accused him of being an imposter and the author of a hoax, but Hunter never had the chance to defend himself. He was in Texas at the time, one of the leaders in a pan-Indian movement for sovereignty, when he was assassinated in the infamous Fredonian Rebellion.

Although Hunter could not have known it at the time, he was at the vanguard of a movement for an inclusive vision of democracy that embraced Indigenous rights and humanity rather than excluding and denying them. Hunter's story is a stark reminder of the work that still must be done to fulfill the promises of the American experiment.

Along the way, readers will develop a newfound appreciation for how robots are transforming exploration—and what these voyages mean for the future of humanity.

The more marine robotics extend our physical and intellectual capacities, the more they challenge us to redefine what it means to coexist with the world around us. The real revolution is just beginning, lying in how these machines will transform our understanding of our environments—allowing us to balance discovery with stewardship by supporting a thriving human society while safeguarding the ecosystems we depend on.

With decades of experience as a college president, Poskanzer examines the growing demands for universities to take official positions on matters ranging from climate change to global conflicts, to current debates over public policy. He argues that universities must be faithful to and focused upon their core mission-advancing knowledge and learning-while carefully navigating the fragile "social compact" between academia and broader society. At the heart of his argument is the "General Rule of Reticence," a principle that universities should be circumspect about adopting institutional positions unless doing so is essential to the pursuit of their mission, including safeguarding academic freedom. But reticence does not mean cowed silence. Poskanzer outlines clear, actionable criteria for when universities can and even must speak out: when they possess unique educational expertise to offer; when speech will ensure a robust intellectual environment for faculty and students; when their mission is at issue; or when their very existence is at risk.

This nuanced framework encourages academic leaders to respond thoughtfully to internal and external pressures to take stances without compromising the long-term integrity of their institutions. *The University's Voice* offers essential guidance for faculty and administrators as well as leaders of other mission-driven organizations and policymakers on how to balance principled silence with purposeful speech in an increasingly polarized world.

Thomas A. Edison started the 1890s as one of the most famous people in the Western world, with his name celebrated in small-town newspapers and imperial courts. However, the changing technological and corporate environments of this decade raised obstacles that Edison could only partially overcome while reorienting his career away from his signature electrical technologies.

The tenth volume of the widely acclaimed series *The Papers of Thomas A. Edison* chronicles the end of the "Battle of the Currents," the contest over the development of US electric utility infrastructure. Edison struggled to adapt his direct-current system to overcome the advantages of the Westinghouse Electric alternating-current system and to outpace Thomson-Houston Electric's development of motors for industry and electric traction. The forced merger with Thomson-Houston that created General Electric in 1892 ended Edison's dozen years of leadership in the electrical business.

Edison remained prolific in other fields documented in this volume sound recording, motion pictures, and batteries. But all these projects were overshadowed by his efforts to revitalize uncompetitive eastern iron mines by concentrating low-grade iron ores. Edison opened a massive ore-concentrating works in Ogdensburg, New Jersey, in 1890. The operation, improvement, and expansion of that plant consumed much of his energy and wealth for the rest of the decade.







### Russia Under Putin

Fragile State and Revisionist Power EDITED BY ANDREW S. NATSIOS

In *Russia Under Putin*, editor Andrew S. Natsios brings together an esteemed group of scholars to explore the complex duality of Vladimir Putin's Russia. As they track Putin's rise from a former KGB officer to one of the world's most powerful leaders, these essays confront an urgent global question: Is Russia a declining state on an unstable foundation, or is it a dangerous, revisionist power?

As the world watches Russia's aggressive foreign policies unfold, Natsios and the book's contributors illustrate how the decline of this nuclear-armed state presents profound risks to global stability. The essays draw comparisons to past authoritarian regimes while offering a stark warning: Even a fragile power can wreak global havoc. Engaging, timely, and thought-provoking, *Russia Under Putin* provides a nuanced view of a country whose ambitions will shape the twenty-first century—for better or worse.

In Great Thinkers and Doers, Teresa Zackodnik looks at the vital—and largely overlooked—role of Black women readers, writers, and editors in the development of the Black press in the nineteenth and early twentieth centuries. Understanding the relationship between the Black press and Black women's political and community organizing helps illuminate how important Black women were to this media phenomenon in its first one hundred years.


In the nineteenth century, Zackodnik reveals, the Black press was second only to the Black church in its centrality to Black politics and communities, but histories of its development have long credited its founding and development to the Black men who were its editors. Despite their underrepresentation in the leadership of Black public politics and the Black press, women were overrepresented in the mutual benevolent, moral improvement, and literary societies that functioned as community centers of political, oratorical, and print culture work. These societies supplied the Black press with content, a readership, and distribution nodes in Black communities throughout the nation.

Zackodnik examines the vital opportunity that this networking of the Black press with literary societies offered Black women readers to enter Black print space and advance communal goals. She also explores how Black women gained a foothold within publications often, initially, with "gateway genres" such as letters to the editor and women's columns—and shaped the Black press. This book will change how we understand the early Black press and overlooked Black feminist print practices.


### The Care of Foreigners

How Immigrant Physicians Changed US Healthcare ERAM ALAM

For more than 60 years, the United States has trained fewer physicians than it needs, relying instead on the economically expedient option of soliciting immigrant physicians trained at the expense of other countries. In *The Care of Foreigners*, Eram Alam examines this migratory dynamic that began during the Cold War.

The passage of the Hart-Celler Immigration and Nationality Act of 1965 expedited the entry of Foreign Medical Graduates (FMGs) from postcolonial South Asia and sent them to provide care in shortage areas throughout the United States. Although this arrangement was conceived as temporary, over the decades it has become a permanent fixture of the medical system, with FMGs comprising at least a quarter of the physician labor force since the act became law. This cohort of practitioners has not been extensively studied, rendering the impacts of immigration and foreign policy on the everyday mechanics of US health care obscure. Alam foregrounds global dynamics embedded in the medical system to ask how and why Asian physicians—and especially practitioners from South Asia have become integral to US medical practice and ubiquitous in the mainstream US public imagination.

Drawing on transcripts of congressional hearings, medical, scientific, and social scientific literature, ethnographies, oral histories, and popular media, Alam explores the enduring consequences of postcolonial physician migration. Combining theoretical and methodological insights from a range of disciplines, this book analyzes both the care provided by immigrant physicians as well as the care extended to them as foreigners.



What happens when rural America—long romanticized in pastoral literature—becomes associated with deficiency, degradation, and decline? Maria Farland's *Degraded Heartland* is the first critical study of US literary antipastoral, a mode that exposes the stark realities of rural poverty and ecological devastation while highlighting the jagged process of modernization in the countryside. It provides a historical account of how ideas of rural backwardness developed in US literary culture.
